## **BIA-MN AGENCY:** Roger Heger

Roger discussed the Nelson Act Funds. The amount returned was \$135,000 to be divided six ways. To collect the monies returned after one year is a decision by each tribe on how to handle. OST can pay the individuals eligible or the tribes. \$135 thousand each, Mille Lacs and Grand Portage collaborated. Pubic Voucher/resolution – mailed back. It's the Tribe's responsibility to decide what to do with monies. End of Nelson act with OST.

Buy Back Program – Fond du Lac will be getting their monies. Willing seller – goes thru OST Staff member – call is logged in at call center. In turn offers are sent out to the willing sellers. Bois Forte sent a letter of intent in 2014 in turn Cobell settled with MCT Buy Back Program for individual tribes.

Levi asked why in 2012 was MCT number 17 on the list and now we are not. Roger will bring in someone to explain how list was derived and referred to Mike in DC. Kevin stated that we are asking people to walk into to a program that is not clear.

Norman asked if there was anyone else from the Bureau to discuss the Secretarial Election. Regulations changed in November and BIA needs to re-access for new regulations. Question is the request was submitted before changes and why hasn't Bureau acted on. The Bureau is ignoring its own deadlines.

Mark stated technical comment and technical review are still in Solicitor's office, it has to be polled by Solicitor. Kevin stated that the Secretarial Election is null and void. Mark responded the law states 90 days, it doesn't state null void. Kevin responded that leave 30 days to educate people.

Roger Heger responded that he would get back to Norman with an answer in regards to the Secretarial Election.

#### **LEGAL**: Mark Anderson

Mark discussed the Tax forfeiture on the MCT Building. Taxes at \$24 thousand, the Minneapolis accessor kept property on tax roll even though it was tax exempt. We should know amount in March for special assessments.

Mark stated the BIA is implement new right away rules which will be in effect March 1<sup>st</sup>. The deadline for the reservations is perfect July. The Bureau should inform the bands and tribes how they will implement the new rules.

Bois Forte/Fond du Lac/Grand Portage payback U.S. under piolet project letter asking for waiver on liens and money collated be return to reservation to buy additional lands.

Melanie stated we need support from bands and educate people as well as MCT.

Carolyn Beaulieu informed the Committee that Mille Lacs is in opposition of the Secretarial Election. There is not enough information on the potential impact of the proposed enrollment changes. Other leaders may want to pursue.
