QUARTERLY REPORTS:

BIA- MN Agency: Eric S. Bruguier, Superintendent

Superintendent Bruguier gives a brief report on BIA MN Agency. Chairman Fairbanks stated that working with Eric has been very helpful, and of great assistance to the White Earth Band, and informed the Committee that this is Eric's last meeting. Secretary/Treasurer McCormick thanked Eric for securing a meeting with Assistant Secretary DOI Bryan Newland at the Partners in Action Conference at our request last TEC meeting and upon hearing it was Eric's last meeting, offered a pound of wild rice and cedar from Grand Portage. President Chavers thanked Eric for his work with the Tribes – it is greatly appreciated.

QUARTERLY REPORTS

President Chavers acknowledged and received quarterly reports for the record.

Update Constitutional Reform meetings: Cheryl Edwards, Sally Fineday – not present nor in Zoom when President Chavers acknowledges them, Committee moves on.

The American Indian Alaskan Native Alliance: Candy Beatty, Tribal Content Developer – not present nor in Zoom when President Chavers acknowledges them, Committee moves on.

MN Interagency Council on Homelessness - not present nor in Zoom when President Chavers acknowledges them, Committee moves on.

Executive Director Drost announced at 9:35 a.m. that Chief Executive Benjamin joined the meeting.

LEGAL: Brodeen & Paulson

Phil Brodeen presented that at the Legislative Subcommittee and TEC meeting last month it was approved to enter into contract with Sara Van Norman, of Van Norman Law, PLLC is contained in your packets. Described Sara's scope for legal services.

BIA has stalled out on holding a Secretarial Election that the TEC requested, the main issue is BIA is not recognizing the MCT's interpretation of the voter threshold and as an extra step requires voter registration. We've sent several correspondences to BIA contained in your packets (8/18/2023, 9/21/23). We've received a letter from BIA on

October 20, 2023, in order for them to move forward they want a written interpretation. Phil recognizes that TEC is uncomfortable with writing interpretation due to TEC's executive duties are not judicial duties and has provided what a 'potential written interpretation' would be in our packets as *Draft Tribal Interpretation 01-2023*. Phil recommends that the Tribal Leaders need to meet with Midwest Agency to communicate exactly what TEC wants the BIA to do, because Phil and Beth have met with them to the extent that it is effective at their level. Recommended not to have a Secretary Election this fall; we need to meet with BIA between now and January in preparation for a spring Secretarial Election and utilize this time to update voters list and get information out to voters.

Committee Members requested that the meeting involve BIA legal alongside Midwest Agency Leadership with a clear timeline, that MCT update voter addresses and provide voter education 'to get the trust back' from the voters.

Discussion was opened about an enrollment ordinance that could be developed without a Secretarial Election. Phil recommended that the election code ad hoc committee could develop a brand-new enrollment code/ordinance by reviewing what other tribes have done, presenting an ordinance that is in line with MCT constitution and offers more interpretation on the enrollment. Chairman Dupuis made a recommendation to go past Midwest agency BIA to D.C. at the federal level once we are prepared with a plan.

Questions from audience members and answers among Committee members occurred.

CONSTITUTIONAL REFORM UPDATE: Sally Fineday is not present. Jolene Danielle, Patty Straub, Michaa Aubid

Jolene presented the committee meetings every month rotating each reservation. Many opinions and the largest hurdle is convening membership. We've reviewed the United Nations Rights for Indigenous People, and we have subcommittees that meet once or twice a week. Biggest focus is the Education and compiling videos. Patty Straub presented membership criteria as a concern for White Earth delegation, and they support 32-15 as a beginning point for increasing enrollment in the future.

President Chavers called on Sally Fineday upon entering the room. Sally presented a letter regarding financial request from the committee. Executive Director Drost, President Chavers and Secretary-Treasurer McCormick offered clarity on process and forms that the Constitution Committee may make several specific requests under the MCT process and forms for the \$100,000 TEC designated for education (not a lump sum disbursement), further final approval by the TEC of the educational series is needed before it is deployed and funding to be received. President Chavers requests that the Constitution Reform Committee finalize the education series because of its importance with the TEC to approve so the funds can be dispersed.

President Chavers, Phil Brodeen and Secretary/Treasurer McCormick offered answers, Natural Resources Subcommittee to take up Climate Change Resolution.
