Chairman Dupuis – it's by statue, what happens if the new office doesn't follow statue. If not in compliance what's going to happen?

Chairman Jackson stated it's a federal law, there would be some serious repercussions.

## **REVISED ELECTION ORDINANCE**: Phil Brodeen

Gender specific, makes it clearer in criminal record – one big change.

Secretary-Treasurer LaRoque did you discuss the way the background checks are being done. Maybe each tribe could utilize the BCA regarding full criminal records. Suggested we stick with state agency that do it. Can't have one time doing it one way and another a different way, uniform for each tribe.

Chairman Jackson like idea of being uniform for the certification process. If you've ever been convicted of a felony, it affects you for life. We want to empower our people, take a serious look at that. Felony of any kind. Our people will never be able to run for office the way it's written today.
