# **BUREAU OF INDIAN AFFAIRS:**

Robert Lintelman presented the BIA report on behalf of Heidi Gordon. He discussed the blowdown impacting the Bemidji area and storm damage; DOGE impacts on BIA offices; BIA hiring freeze. Lintelman noted the process designed for allottees and individual land owners explaining to them what they can and cannot do with their allotments will continue. He concluded by reading a note from Superintendent Patricia Olby, who will remain the Superintendent in Bemidji. Lintelman responded to questions regarding BIA restructuring. TEC members expressed concern regarding lack of consultation with Minnesota tribal nations.

Motion by Secretary-Treasurer Leonard Fineday that the TEC formally request that the Secretary of Interior consult by meeting with tribal governments in Minnesota. Seconded by Secretary-Treasurer Wayne Dupuis. .

MCT CONSTITUTIONAL REFORM DELGATES: Constitutional reform delegates presented their reports on behalf of their respective Bands.

**Leech Lake:** Delegate Sally Fineday reported that Leech Lake would like the TEC to take action to move ahead.

**Fond du Lac**: Delegate Cheryl Edwards reported that delegates heard or came away with differing interpretations of a request from the TEC at the May 6, 2025, meeting, and requested that in the future, a written summary of requests of delegates be sent to delegates after each TEC meeting.

**Grand Portage:** Delegate Marcie McIntire reported about two models for writing a new constitution that are being discussed at Grand Portage.

**Mille Lacs of Ojibwe**: Delegate Danielle Smith reported that MLB is convening a constitutional convention with assistance from the Native Governance Center.

White Earth: Delegate Jolynn Donnell reported that WE Delegates support removing the Secretary from the amendment process but want to see what it will be replaced with. (No presentation from Bois Forte Delegation)

Delegates noted upcoming meetings: Friday, July 18<sup>th</sup> for all band delegations, and August 8<sup>th</sup> and December 12<sup>th</sup> meetings at Grand Casino Mille Lacs.

#### **LEGAL UPDATE:**

Phil Brodeen, Brodeen & Paulson, presented the legal update and read aloud and explained Resolution 90-25, which was adopted by the Legislative Subcommittee. Resolution 90-25 is a process resolution that responds to BIA request that the MCT interpret whether 30% of eligible voters means all MCT voters who are 18 and older and otherwise eligible to vote should they choose to do so, or 30% of all voters who are eligible to vote because they are duly registered to vote in that particular election. The resolution expresses that the TEC is reverting back to the number of duly registered voters for purposes of establishing the 30% threshold.

Legislative Subcommittee Chairman Leonard Fineday explained the purpose of the Resolution which it recommended for passage by the TEC. TEC Members asked questions and discussed their support for or concerns about the resolution.

Chairman Mike Fairbanks motioned to table Resolution 90-25, seconded by Chief Executive Virgil Wind.

Members discussed the motion.
